Hello Eric,

Thank you for the letter. Attached please find the form that you requested to change the VP's withholdings. Our records indicate that we changed the state withholding to DC from Delaware effective the date the VP was sworn in. This change was reflected on the payroll information notices that the VP has been receiving every pay period. The VP claims a federal status of married with 0 exemptions and claims an additional withholding of \$70 per month. He also claims a status of married for state taxes with 12 exemptions. We will look for the documentation that you requested in his personnel folder, but I wanted to provide you this information as quickly as I could.
